Description

Invitation to Bid for RESTORATION OF DENR XI REGIONAL OFFICE BUILDING

1. The Department of Environment and Natural Resources RXI through the General Appropriation Act of CY 2020 intends to apply the sum of One Million Twenty-six Thousand Fourteen Pesos and 98 Centavos (Php. 1,026,014.98) being the Approved Budget for the Contract (ABC) to payments under the contract for Restoration of DENR XI Regional Office Building (PR# 20-10-386) Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Department of Environment and Natural Resources RXI now invites bids for the restoration of DENR XI Regional Office Building; the provision of materials, equipment, tools, accessories, labor and supervision for the complete infra works of the subject project Completion of the Works is required Ninety (90) calendar days. Bidders should have completed at least one contract that is similar to the Project to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from DENR RXI Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below from 8:00 A.M. – 12 Noon and 1:00 P.M. – 4:30 P.M.

5. A complete set of Bidding Documents may be acquired by interested bidders on October 12, 2020 from the address below and upon payment of a non- refundable fee for the Bidding Documents in the amount of One Thousand Five Hundred Pesos Only (P1,500.00)

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Department of Environment and Natural Resources RXI will hold a Pre-Bid Conference on October 21, 2020 @ 2:00 p.m. at DENR XI Regional Office Conference Room, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before November 3, 2020, not later than 10:00 A.M. at the DENR RXI, Lanang, Davao City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
Bid opening shall be on November 3, 2020 @ 11:00 A.M. at DENR XI Regional Office Conference Room. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
NOTE: Bidders must attach a table of contents and paste a page-tag for a quick way to locate the desired document.

The Department of Environment and Natural Resources RXI reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
